Rwandan Franc (RWF)

US Dollar and Euro are also commonly accepted

## 9. **Visa requirements**

Visa requirements for citizens of the AAQS member countries are as follows: It is the responsibility of the traveler to confirm current details relating to specific circumstances using the following link: <https://migration.gov.rw/>

Travelers from all countries can obtain a visa upon arrival for 30 days, without prior request for \$50 for single entry and can be paid in cash (Sterling, US dollars or Rwandan francs) or by Visa/MasterCard. A visa can also be bought online ahead of travel (this must be completed at least 72 hours in advance of arrival). The applicant will receive a response from the immigration authorities within 3 days. This response must be printed and handed over to the border control of immigration on arrival.

### **General**

Delegates should, however, themselves check the visa requirements. The AAQS and/or RIQS will provide a letter of invitation where required

## 10. **Health**

### **COVID-19 Entry Requirements**

Individuals travelling to Rwanda are no longer required to provide proof of vaccination or a negative test result

### **Yellow fever**

Rwanda requires a valid yellow fever certificate from all foreign visitors and citizens over 1 year of age travelling from an infected area or having been in transit through infected areas (>12 hours) in the last 6 days.

Yellow fever vaccination should be approved by the World Health Organization (WHO) and administered at least 10 days before departure to Rwanda at any yellow fever approved vaccination centre as the vaccine offers protection from 10 days after administration. If vaccination is administered less than 10 days before departure, the traveler may be refused entry

List of Institution Member countries for which a yellow fever vaccination certificate is required for entry into Rwanda (however, delegates to reconfirm):

Angola  
The Gambia  
Ghana  
Nigeria  
Uganda

There is no yellow fever risk in Rwanda. Therefore, the country requires a yellow fever vaccination certificate from those travelling from the following countries (travel includes transit stays that surpass 12 hours): Angola, Argentina, Benin, Bolivia,

Brazil, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Colombia, Congo, Cote d'Ivoire, Democratic Republic of Congo, Ecuador, Equatorial Guinea, Ethiopia, French Guyana, Gabon, Gambia, Ghana, Guinea, Guinea Bissau, Kenya, Liberia, Mali, Mauritania, Nigeria, Panama, Paraguay, Peru, Senegal, Sierra Leone, South Sudan, Sudan, Suriname, Togo, Trinidad and Tobago, Uganda, and Venezuela.
